

What is the Summary Annual Report?

The Summary Annual Report (SAR) is a summary of a retirement plan's financial information. The following report provides a financial snapshot for FREMONT UNION EMPLOYEES 401(K) PLAN from January 01, 2025 through December 31, 2025.

Its purpose is to summarize information on the plan's annual report for current participants, former participants with an account balance and/or beneficiaries of a participant.

You are not required to take any action, but you can request a copy of the full annual report or any individual parts of the report at any time.

Summary Annual Report for FREMONT UNION EMPLOYEES 401(K) PLAN

This is a summary of the Form 5500-SF Annual Return/Report of Small Employee Benefit Plan of FREMONT UNION EMPLOYEES 401(K) PLAN, EIN 87 3643212, for January 01, 2025 through December 31, 2025. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer 401(k) plan.

Basic financial statement

Benefits under the plan are provided by an insurance contract and a trust fund. Plan expenses were \$329,969. These expenses included \$4,591 in administrative expenses, \$325,378 in benefits paid to participants and beneficiaries and \$0 in other expenses. A total of 48 persons were participants in, or beneficiaries of, the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$2,076,785 as of December 31, 2025, compared to \$2,062,762 as of January 01, 2025. During the plan year, the plan experienced an increase in its net assets of \$14,023. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of plan's assets at the end of the year and the value of the assets at the beginning of the year or cost of assets acquired during the year. The plan had a total income of \$343,992, including employer contributions of \$55,303, employee contributions of \$68,236, and earnings from investments of \$220,453.

Your rights to additional information

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- Financial information
- Insurance information including sales and commissions paid by insurance carriers
- Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates

The charge to cover copying costs will be \$1.00 for the full annual report or \$.10 per page for any part thereof. You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan:

The plan has been issued a fidelity bond by Liberty Mutual in the amount of \$5,000,000. The bond protects the plan against losses through fraud or dishonesty and covers any person handling plan assets. You have the right to examine or receive from the plan administrator, on request and at no charge, copies of statements from the regulated financial institutions noted above describing the qualifying plan assets and evidence of the required bond.
